

# Orienteering Australia selection arrangements for 2022 Australian WMTBOC/JWMTBOC team

## 1. Background

### 1.1 Australian Teams for 2022

This document sets out selection arrangements for the following elite Australian MTB orienteering team in 2022:

- World MTB Orienteering Championships
- Junior World MTB Orienteering Championships

They reflect input from Australian and overseas-based elite athletes; coaches, experience from past selection processes and general selection guidelines published by the Sports Australia. They also reflect Orienteering Australia's rules.

### 1.2 Changes to WMTBOC format

The number of athletes which a country is permitted to enter in the long distance finals is limited, so a rider's entry is not automatic. If entries for the long distance exceed 66, then pre-qualification steps come into play to determine how many riders a country can field.

In accordance with the OA rules, members of the selection panel will not vote or take part in discussion on selection of the class in which he or she, or a member of his or her immediate family, or a partner, is a contender for selection.

## 2. 2022 World MTB Orienteering Championships (WMTBOC/JWMTBOC)

The World Champs are in Sweden from 15-20 July.

### 2.1 Team size

The WMTBOC and JWMTBOC team will each ideally consist of at least 3 men and 3 women, provided that the available athletes clearly demonstrate their potential to reach the final in the races in which they compete.

Additional team members will only be selected based on their potential to reach the top 60, up to a maximum of 6 men and 6 women, noting that a maximum of 3 athletes can be selected for any discipline.

The team will be announced shortly after the selection trials.

- Given Australia's limited resources to support a large team and the possibility of injury or change in form, it is desirable that athletes can perform at the international level in more than one discipline.

- However, specialisation in a single discipline (and particularly in the sprint discipline) will be supported where the athlete is perceived to have outstanding ability in that discipline.
- The selectors will recommend rider for the relay team with final selection by the Head Coach to be made during the carnival, based on individual performances. Teams may be a blend of Senior, Junior, Male and Female riders, where sufficient riders are not available for a class.

**Reserves** may be announced but there will be no funding for them to travel to or train with the team overseas.

The selectors will name the participants for each discipline of WMTBOC, excluding the relay, when the team is named.

Each team member will ride at least two disciplines, subject to them not suffering from significant illness or injury or substantial loss of form. At the discretion of the MTBO Head Coach and MTBO Assistant Coach, fitness tests may be conducted and selected athletes may be withdrawn from the team should sufficient fitness not be demonstrated.

Any decision on changes to the races which athletes ride will be made by the MTBO Head Coach in consultation with the OA High Performance Manager, as per OA Operational Manual Section 5.1. Decisions regarding each participant's races will take into account rider's preferences, form, fitness, and injury and illness status at the time. Athletes should understand that they have a responsibility to disclose any significant injury problems to team management upon occurrence.

If the Head Coach suggests an athlete ride a discipline for which they weren't initially selected then the reasoning behind this decision will be conveyed to the Manager, High Performance and Chair of Selectors in a timely fashion, preferably before the event takes place.

The selection and order of the relay team will also be decided by the OA Head Coach, in consultation with the Team Manager/Assistant Coach, with athlete input. This may take place during carnival week.

### **2.3 Selection trials and criteria**

Team selection in 2022 will be based on the following criteria:

(i) Primary (i.e. most important) criteria

1. Results in the selection trials listed below;

(ii) Secondary criteria, in order of importance:

1. Past international performance, particularly at WMTBOC or JWMTBOC

2. Recent performance at major Australian events within the last 12 months

3. Previous Australian performance;

(iii) Ability to relate well within a team atmosphere.

Athletes are reminded that in accordance with the Orienteering Australia operational manual, priority will be given to selecting a team which can be expected to behave in a harmonious and responsible manner. Past unacceptable behaviour by an orienteer will be taken into account by the selection panel.

Selection will be largely evidence-based. It will analyse event results to determine who is likely to achieve the best results at the WMTBOC or JWMTBOC. While the selection panel will take all relevant factors into consideration, the strongest cases for selection will be those that meet both the primary and secondary criteria.

Those athletes who do not have past international results which prove that they are capable of making finals will need to rely on results at the trials to demonstrate that they are better prospects at WMTBOC or JWMTBOC 2022 than those who have performed well at WMTBOC or JWMTBOC in previous years.

Within the constraints of team size, outstanding performance in individual selection races will be rewarded with selection, in recognition that athletes who can achieve outstanding trial results are more likely to be able to achieve top 20 performances at WMTBOC or JWMTBOC.

When two athletes have very similar performance, based on the criteria above, selection will have regard to potential for future development, including factors such as age, experience and riding speed.

### **2.2.1 The Primary WMTBOC/JWMTBOC 2022 Criteria - Selection Trials**

The Australian selection trials for 2022 will cover:

- all stages of the selection trials.

To give everyone a fair and open chance for selection, all Australian-based athletes shall compete in the Australian selection trials and overseas based athletes are strongly encouraged to do so. Selection trials provide the most recent guide to form. Within practical constraints of timing and venue, the trials provide a situation of pressure to perform on the day, a feature of WMTBOC and JWMTBOC.

Absence at selection trials will be normally be taken as an indication that the athlete is uncompetitive relative to others at the time. Anyone who is unable to compete in one of the sets of selection trials (e.g. through injury, illness or absence overseas) will be required to advise the Chair of Selectors stating the reasons for the absence. If the absence is due to injury or illness a medical certificate shall be provided.

There are no absolute measures of performance (ie times and records) so relative performance compared to other athletes vying for selection will be crucial to the selection process.

In accordance with the Orienteering Australia operational manual, the selection panel will take account of any exceptional circumstances affecting the performance of candidates in the selection trials; however, the onus is on the candidate to advise the Chair of Selectors in writing of these exceptional circumstances.

Given that some selection races will be ride on areas previously used, the selection panel may also take into account competitors' training or competition experience in these areas.

### **2.2.2 Overseas selection races**

It is desirable that all nominees attend the Australian based trials.

However, for nominees who may be living overseas, selection trials can be arranged around existing o/s events in negotiation with the chair of selectors. In such a situation the nominee would have to clearly demonstrate results that leave no doubt that they are significantly better than the next ranked Australian nominating for that particular class.

### **2.3.3 The Secondary WMTBOC/JWMTBOC 2022 Criteria – Past Performance**

This includes results in the following events in order of reducing importance:

#### **Past International Performance**

- World Championships;
- World Ranking events;
- JWMTBOC
- Other major international MTBO races
- Australia – New Zealand Challenge, Oceania Championships and other regional international championships
- National MTB Orienteering League rounds

#### **Pre-selection**

Upon application from the athlete, the Selection Panel may pre-select one or more athletes. This will only be done in circumstances where the athlete has:

- outstanding previous international performances within the past 2 years
- a demonstrated high level of current fitness.

### **2.3.4 Other Considerations**

No outstanding debts to Orienteering Australia, Australian University Sport or the athlete's relevant state association.

## **2.4 Nominations and team announcements**

It is important that all athletes who wish to be considered for selection in national teams and squads inform the OA Head Coach and OA Manager - High Performance of their current contact details.

All athletes shall ensure they conform with the OA operational manual with regard to anti-doping provisions and the maintenance of up to date contact details with ASADA, if required. Failure to meet such obligations may result in an athlete's nomination for selection being refused.

All athletes who wish to be considered for selection in the Australian 2022 WMTBOC or JWMTBOC team will be required to submit a nomination web form **by midnight 21st March 2022**.
